SCHEDULE 1 TO ORDER OF 12 SEPTEMBER 2013

1. Thames Valley Police will give full and reasonable consideration to the reinstatement of 6 monthly liaison meetings with residents living in the vicinity of TVP HQ South with the objective of avoiding any unreasonable impact of operational activities on local residents. It is noted that Mr Makepeace's proposal is that such meetings would include local residents, parish council representatives and a senior officer or senior member of staff, and that his proposal is that the first such meeting should take place by 30 November 2013.
2. The appeal and the original request are withdrawn.
3. It is noted that if TVP are unable to agree to the meetings specified at item 1 above by 30 September 2013, then Mr Makepeace will submit a fresh FOI request for information relating to 6 January 2011.
